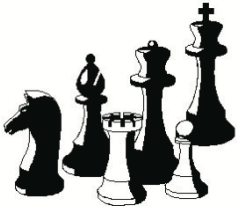

All dues may be paid with advance entry fee or at door. **Registration for at-door entrants: 8:30 to 9:30 AM on Saturday, February 25.**

Rounds will start at 10:00, 1:00, 3:30, 6:00. Half-point bye available for any one round, if requested before Round 2. No half-point bye for player receiving full-point bye.
