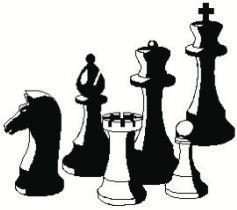

All dues may be paid with advance entry fee or at door. **Registration for at-door entrants: 8:30 to 9:30 AM on Saturday, March 1.**
